Ali Ajalli

Case No. 2012-052921

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$500.00 plus costs and seventeen hours of continuing education against Ali Ajalli's license to practice architecture. Mr. Ajalli affirmed at renewal that he had completed the required continuing education credits. Mr. Ajalli was chosen for the audit and has provided only 13 hours of continuing education.

William Robert Bingham

Case No. 2013-039598

The Florida Board of Architecture and Interior Design agreed to enter a final order relinquishing William Robert Bingham's Florida license to practice architecture.
