### **I. Unlicensed Cases**

#### **Balda Interiors**

**Aimee N. Balda**

**Case No. 2011-061123**

Probable cause was found that Balda Interiors and Aimee N. Balda of Indian Harbour Beach, FL, are not licensed to practice architecture in Florida and are offering architectural services on its website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Ms. Balda sign an affidavit stating she has changed her website and will not offer such services in the future. If Ms. Balda fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

#### **David C. Bishop**

**David Bishop Design**

**Case No. 2012-000392**

Probable cause was found that David C. Bishop and David Bishop Design of Naples, FL, are not licensed to practice architecture in Florida. Mr. Bishop is using the phrase architectural design. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Bishop sign an affidavit stating that he has changed his materials and will not offer such services in the future. If Mr. Bishop fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

#### **Blue Water Engineering & Design, Inc.**

Probable cause was found that Blue Water Engineering & Design, Inc., Richard E. Hopkins, Inc. and Richard E. Further, Mr. Hopkins is offering these services through a corporation without a certificate of authorization. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

Probable cause was found that Gary Cousineau and Bath & Kitchen Creations, Inc. of Boca Raton, FL, are not licensed to practice architecture in Florida and are offering architectural services on its website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Cousineau sign an affidavit stating he has changed his website and will not offer such services in the future. If Mr. Cousineau fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Shuster Design Associates, Inc.**

**Case No. 2011-053479**

Probable cause was found that Dennis Dezmain and Shuster Design Associates, Inc. of Wilton Manors, FL, are not licensed to practice architecture in Florida and are offering architectural services on its website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Dezmain sign an affidavit stating he has changed his website and will not offer such services in the future. If Mr. Dezmain fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Jeffrey Gilger**

**S. Jeffrey Gilger Design Services, Inc.**

**Case No. 2011-040956**

Probable cause was found that Jeffrey Gilger and S. Jeffrey Gilger Design Services, Inc. of Oviedo, FL, are not licensed to practice architecture in Florida and contracted to provide architectural services on a residential project. Further, Mr. Gilger is offering these services through a corporation without a certificate of authorization. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

## **Soney FM, LLC**

### **Case No. 2012-008402**

Probable cause was found that Ram A. Goel and Soney FM, LLC of Tampa, FL, are not licensed to practice architecture in Florida; however Mr. Goel is a licensed Professional Engineer. Mr. Goel is offering architectural services on his website. Further, Mr. Goel is aiding a firm in the unlicensed practice of architecture. An Administrative Complaint seeking fines will be filed.

## **Loren Design Projects, LTD**

### **Andrea Loren**

### **Case No. 2011-053454**

Probable cause was found that Loren Design Projects, LTD and Andrea Loren of Delray Beach, FL, are not licensed to practice architecture in Florida and are offering architectural and commercial design services on its website. Further, Ms. Loren is offering these services through a corporation without a certificate of authorization. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

## **Sharron Lewis Design Corporation**

### **Jihad Doujeiji**

### **Case No. 2012-003574**

Probable cause was found that Sharron Lewis Drafting Corporation and Jihad Doujeiji of Miami, FL, are offering commercial interior design services on its website. A Notice and Order to Cease and Desist from offering commercial interior design services was issued along with the requirement that Mr. Doujeiji sign an affidavit stating he has changed his advertising to delete all references to commercial interior design. If Mr. Doujeiji fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

## **II. Licensed Cases**

### **Orestes L. Lopez-Recio**

### **Case No. 2011-019126**

Orestes L. Lopez-Recio is licensed to practice architecture in the State of Florida and entered into a contract to provide permit ready drawings but failed to do so. An Administrative Complaint seeking discipline will be filed.

### **Roy D. Murphy**

**Case Nos. 2011-061204 & 2011-055294**

Roy D. Murphy is licensed to practice architecture in the State of Florida and signed and sealed plans for a commercial project that were prepared by an unlicensed draftsman. Mr. Murphy has been unable to provide the proper documentation for signing and sealing drawings prepared outside of his office. An Administrative Complaint seeking discipline will be filed.
