### I. Unlicensed Cases

#### **All Architecture, Inc.**

**Majed M. Hawari**

**Case No. 2010-053536**

Probable cause was found that All Architecture, Inc. and Majed M. Hawari of Tampa, FL, are not licensed to practice architecture in Florida and provided architectural services on a commercial project. Further, Mr. Hawari is doing business as All Architecture, Inc. and is offering these services through a corporation without a certificate of authorization. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

#### **Architectural Dynamics**

**Joyce L. Phipps**

**Case No. 2011-010770**

Probable cause was found that Architectural Dynamics and Joyce Phipps of Orlando, FL, are not licensed to practice architecture in Florida and provided architectural services on a commercial project. Further, Ms. Phipps is doing business as Architectural Dynamics and is offering these services through a corporation without a certificate of authorization. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

#### **Decker Ross Interiors, Inc.**

**Suzan Decker Ross**

**Case No. 2009-056782**

Probable cause was found that Decker Ross Interiors, Inc. and Suzan Decker Ross of Clearwater, FL, are not licensed to practice interior design in Florida and is holding herself out as a licensed interior designer. A Notice and Order to Cease and Desist from offering licensed interior design services was issued along with the requirement that Ms. Decker Ross sign an affidavit stating she

has changed her advertisements to delete all references to licensed interior design until properly licensed.

**Michael W. Finch**

**Case No. 2010-047394**

Probable cause was found that Michael W. Finch of Largo, FL, is not licensed to practice architecture in Florida and contracted to provide architectural services for a commercial project and used the title architect. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

**Scott Raymond**

**Case No. 2011-010774**

Probable cause was found that Raymond Scott of Orlando, FL, is not licensed to practice architecture in Florida and is using the title architect. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Raymond sign an affidavit stating he will no longer use the title architect. If Mr. Raymond fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Michel A. Rodriguez**

**Case No. 2011-009347**

Probable cause was found that Michel A. Rodriguez of Miami, FL, is not licensed to practice architecture in Florida. Mr. Rodriguez is a Professional Engineer and signed and sealed drawings containing the title block of an unlicensed firm doing business as C-n-D Architecture, Inc. An Administrative Complaint seeking fines will be filed.

**SS Drafting**

**Soraya Silva**

**Case No. 2010-054146**

Probable cause was found that SS Drafting and Soraya Silva of Chattanooga, TN, are not licensed to practice architecture in Florida and are offering architectural services on its web site. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Ms. Silva sign an affidavit stating she has changed her web site and will not offer such services in the future. If Ms. Silva fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Stiles- Sowers Construction, Inc.**

**Keith Sowers**

**Case No. 2010-058635**

Probable cause was found that Stiles-Sowers Construction, Inc. and Keith Sowers of Naples, FL, are not licensed to practice architecture in Florida and are offering architectural services on its web site. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Sowers sign an affidavit stating he has changed his web site and will not offer such services in the future. If Mr. Sowers fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**TECHNICAD of Volusia County, Inc.**

**Joe Hiller**

**Case No. 2010-056156**

Probable cause was found that TECHNICAD of Volusia County, Inc. and Joe Hiller of Port Orange, FL, are not licensed to practice architecture in Florida and are offering architectural services on its web site. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Hiller sign an affidavit stating he has changed his web site and will not offer such services in the future. If Mr. Hiller fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**WG Professional Drafting Services**

**Wilfredo Guzman**

**Case No. 2010-056148**

Probable cause was found that WG Professional Drafting Services and Wilfredo Guzman of Davie, FL, is not licensed to practice architecture in Florida and offered and provided commercial design services. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

**II. Licensed Cases**

**Robert Michael Graham**

**Case No. 2010-059170**

Robert Michael Graham is licensed to practice architecture in the State of Florida, and has failed to comply with the terms of a Final Order that was entered on July 7, 2008 by failing to pay a \$500.00 fine. An Administrative Complaint seeking discipline will be filed.

**Nicole Hollant**

**Case No. 2010-059274**

Nicole Hollant is licensed to practice architecture in the State of Florida, and has failed to comply with the terms of a Final Order that was entered on December 1, 2009 by failing to pay a fine of \$1,156.00. An Administrative Complaint seeking discipline will be filed.

**VIA Design Studio**

**Case No. 2011-025673**

Via Design Studio is a licensed architectural firm in the State of Florida, however, it held out an unlicensed employee as a project architect in a proposal. An Administrative Complaint seeking discipline will be filed.
